15% Management quota will be applicable to all the colleges including Minority Colleges as per University Circular No. Spl. Cell/(68)/218/2005 dated 3<sup>rd</sup> June, 2005.

1. In house and Minority Students be admitted first as per the practice followed in the proceeding years for admission of F.Y.B.A./ B.Sc./B. Com. Classes only.

3. No Colleges shall conduct their own CET test for admission for any course of University unless it is an Autonomous College.
