Sir,

This has a reference to your letter No.1755/AF/MPVV(PG), dated 22nd August, 2006 requesting permission to start M. Com. degree course in Accountancy (by papers) and in Management (by papers), from the academic year 2007-2008.

In this connection, I am directed to inform you that considering the permission granted by Higher and Technical Education Department of Government of Maharashtra and after submission of undertaking as required on 'India Non Judicial' stamp paper of Rs.100/- to the Joint Director, Higher and Technical Education, Mumbai Region and the acknowledgement of the same is received by the University from the Joint Director, Higher and Technical Education, in exercise of the powers conferred upon Vice-Chancellor under 14 (7) of the Maharashtra Universities Act 1994, your college has been permitted to start M. Com. degree course in Accountancy (by papers) and in Management (by papers), for the academic year 2007-2008 only, on permanent no grant basis subject to pending the report of local inquiry committee to be appointed by the University and also on the following conditions:-

1. The college shall not enroll more than 60 students for M. Com. degree course in Accountancy (by papers) and in Management (by papers), in each subject as per provision laid down in the syllabus prescribed by the University by following the reservation policy of State Government and on the merit.
2. If, your college could not start the said course during this current academic year, the permission granted to your college for the same will be treated as cancelled.
3. the college will charge the fee for the course as prescribed by the University and University's share of tuition fee will be remitted to the University regularly.
4. Report of the Local Inquiry Committee will be binding on your college and conditions, if any laid down therein will be required to fulfill by the college in time specified thereunder.
5. the permission is granted permanently on non-aided basis.
6. Rules, regulations, directions issued by the State Government and the University will be followed by your college.
7. Admission, preparations of teaching programme and payment of remuneration to recognized Post-graduate teachers engaged in teaching programme is the responsibility of the college.
8. that the college will appoint eligible qualified teaching and non-teaching staff as per the U.G.C. and University norms and also make available the necessary basic facilities.

You are therefore, requested to submit the necessary undertaking stating that your college will fulfill the above conditions and also send your proposal for extension of affiliation for the said course on or before 31st August, 2007, for the academic year 2008-2009.
